#### General

## **Cost Structure:**

#### On Monthly Retainer - month to month

A company can purchase any amount of hours at the beginning of each calendar month at R800 per hour (a discounted rate of R50 per hour).

Retainer Hours are paid monthly in advance on or before the 30<sup>th</sup> of the month prior to when the services are required - no minimum monthly purchase required, but if no hours are purchased monthly in advance, hours will be billed at the

"outside the monthly retainer rate" of R650 per

Unused hours can be carried over and hours are flexible as and when needed by the client. No contracts - month to month usage paid in advance.

## On Annual Retainer Contract (ARC) - paid monthly

We will discount our standard hourly billable rate of R850 per hour as follows:

- 20 hours per month: R650 per hour, therefore R13 000 per month;
- 30 hours per month: R600 per hour, therefore R18 000 per month;
- 50 hours per month: R550 per hour, therefore R27 500 per month; and
- 70 hours per month: R500 per hour, therefore R35 000 per month.

Unused hours are carried over and will only expire after 1 year.

Very flexible as additional hours can be secured monthly in advance at your current annual retainer rate and the contract can be terminated by giving two (2) calendar months' notice.

## • Outside the monthly retainer

R50 per hour will be added to the ARC rate and invoiced on the 25<sup>th</sup> of each month and payable with Retainer hours on or before the 30<sup>th</sup> of the same month

Client will be billed on the 25<sup>th</sup> of each month for work done with detailed billing provided, first applying any available Retainer hours and then the charge for hours outside the monthly retainer. The balance due is payable at month-end with the next month's retainer amount.

### Other expenses

Travel cost at R4,00 per kilometre. All other expenses such as toll charges are charged at our cost.
